The restoration needs to blend in with the adjacent tissue and to mask the potentially stained underlying tooth structure.

CLEARFIL MAJESTY™ ES-2 Universal accomplishes this task with one universal shade used independent of the tooth colour thanks to Kuraray Noritake Dental's Light Diffusion Technology. The composite integrates easily and smoothly into the surrounding tooth structure and even dark stains at the cavity floor become invisible under the material that absorbs, scatters and diffuses light in the right way. There is no need for the application of a blocker or opaquer to conceal visual flaws in your regular cases.



SIMPLIFIED POSTERIOR RESTORATION PROCEDURE ELIMINATING SHADE SELECTION

Efficiency is an important factor when it comes to restoring posterior cavities with resin composite. It may be achieved by selecting a material that eliminates the need for shade selection and by the use of simplified layering techniques, for example. In the clinical case below, a maxillary first molar and second premolar were restored with CLEARFIL MAJESTY™ ES-2 Universal (U) using the single-shade technique.



Initial situation. Caries lesions are detected on the occlusal and palatal surfaces of the first molar, and in the distal aspect of the second premolar. Rubber dam was placed for moisture control.



Appearance of the teeth following caries removal, selective etching of the enamel, and application of CLEARFIL™ SE BOND 2.



Sectional matrix in place. It is used to facilitate the creation of a proper interproximal contact.



Occlusal view of the final restorations produced with CLEARFIL MAJESTY™ ES-2 Universal.



Mesio-occlusal view of the final restorations. The surfaces were polished with Kuraray Noritake polishing discs.
